# **EHDI in Tennessee: Developing Collaborative Partnerships over Time**

Tennessee Department of Health's Newborn Hearing Screening (NHS) Program began in 1996 through HRSA technical assistance from the Marion Downs Center. Early partnerships included the Department of Education's Early Intervention Services (i.e. Part C), audiologists, hospitals, and parents. In 2001, Human Resources Services Administration (HRSA) funding was used to employ an audiology consultant and a parent consultant. In the same year, NCHAM began providing technical assistance to TN EHDI. TN EHDI is now working with more than 20 key stakeholders, 80 birthing hospitals, birthing centers, and midwiferies, and 70 audiology centers to provide hearing screening and follow-up services to ~90,000 babies born in TN each year.

#### Successes

- Audiology Consultant and Deaf Educator/Family Outreach Consultant contracted to provide state wide consultation and training
- Parents of children who are deaf and hard of hearing have been involved with all aspects of program development, assessment, community outreach and parent-toparent support in an ever expanding role
- Collaboration with the Tennessee Disability Coalition to contract for parent support through the Family Voices Parent 2 Parent model and now the Hands & Voices Guide-By-Your-Side model
- Active collaboration by stakeholders to contribute to the development of policy, planning and quality assessment
- The provision of scholarships for parents, TEIS, audiologists, and others to attend National EHDI Conferences and state and local trainings
- Collaboration between State agencies and programs that provide services for children with special health care needs
- Increased in the number of Central Office staff participating in EHDI activities

### Challenges

- Limited continuous EHDI training for medical providers and efforts in recruiting them to the statewide NHS Task Force or for program consultation
- Limited funds to purchase hearing screening equipment for hospitals, audiologists, midwives
- Delays in the implementation of a web-based data system to enable hospital reporting of screening/follow-up and audiology reporting of hearing follow-up and the importing of hearing results from hospital equipment
- Limited number of TN NHS staff to assist with EHDI program

### **Future Directions**

- Continue to engage and mobilize new stakeholders
- Focus on reaching 1-3-6 goals and target the reduction of lost to follow-up
- Outreach to medical home providers
- Complete implement of the web-based data system


